#### Annex A

#### Mobile Interconnection Service Tariff ("Tariff")

- 1. This Tariff is offered by Hong Kong Telecommunications (HKT) Limited ("**HKT**") under its Unified Carrier Licence No. UCL-008 for the provision of mobile telecommunications services.
- 2. This Tariff applies to the holder of a Fixed Telecommunications Network Services Licence, Fixed Carrier Licence or Unified Carrier Licence who provides fixed telecommunications services ("**Fixed Telecommunications Licensee**") and to the holder of a Mobile Carrier Licence or Unified Carrier Licence who provides mobile telecommunications services ("**Mobile Telecommunications Licensee**") (collectively "**Licensee**").
- 3. Any Licensee who directly or indirectly passes or receives traffic of the types specified in clause 5 below with HKT shall be deemed to have accepted this Tariff.
- 4. If there is an applicable interconnection contract or other relevant agreement between HKT and the Licensee concerned for a particular type of call covered by this Tariff then the parts of this Tariff that are relevant to that particular type of call shall not apply.

#### Charges

5. The following charges shall be payable by the Licensee to HKT from the effective date of this Tariff:

	Type of Call	Charge per Occupancy Minute
(i)	Local Call Termination	
	Local calls originating from the Licensee's network and terminating on HKT's network regardless of whether or not the Licensee's network is directly or indirectly connected to HKT's network.	HK\$0.30
(ii)	External Call Origination	
	Outgoing external telecommunication calls originating from HKT's network and routed via the Licensee's network regardless of whether or not the Licensee's network is directly or indirectly connected to HKT's network	HK\$0.30
(iii)	External Call Termination	
	Incoming external telecommunications calls routed via the Licensee's network and terminating on HKT's network regardless of whether or not the Licensee's network is directly or indirectly connected to HKT's network	HK\$0.30

# Payment

- 6. HKT shall invoice the Licensee for the charges on a monthly basis.
- 7. The Licensee shall settle the invoices within 30 days from the date of the invoice ("**Due Date**") in full without set-off or counter-claim and free and clear of any withholding or deduction.
- 8. If the invoice is not settled by the Licensee by the Due Date, HKT may charge interest on the amount outstanding at a rate of 2% per annum over the prevailing best lending rate for Hong Kong Dollars offered by the Hongkong & Shanghai Banking Corporation in Hong Kong.

#### Terms & Conditions

- 9. Any terms and conditions not specified in this Tariff shall be covered by HKT's General Conditions of Service.
- 10. HKT may vary the terms, conditions and rates contained within this Tariff at any time.
